




Q3 Do you currently have LVN(s) working in your naturopathic practice?











Q9 Do you currently hold an IV therapy specialty certification with our Board?





Q10 Do you [personally] practice IV therapy in your office?





Q11 If you [personally] are currently certified and practice IV therapy, do you supervise an LVN to assist with IV therapies in your office?





Q12 Are you familiar with the LVN scope surrounding IV therapy administration per California Business and Professions Code section 2860.5?




