
### Task Force Charge & Objectives

- The Corporation shall establish, maintain, and promote the observance of a Code of Ethics to guide members in the duties of (a) physicians to patients; (b) physicians to physicians and other health care providers and (c) physicians to the public
- The creation, maintenance and promotion of the Code of Ethics shall be a responsibility of the House of Delegates, as a matter of policy
- The House of Delegates shall invite, promote, and consider the widest reasonable debate and comment before amending the Code of Ethics

## Task Force: First Draft Overview

- <u>Reviewed AANP's Current Code of Ethics</u> and nine additional healthcare organizations codes of ethics policy statements
- Identified content that was desirable, organization of content that made it easy to read and understand, and clarity of language for adopting and utilizing in one's practice
- Revised AANP content under the well known and established Four Pillars of Medical Ethics - while ensuring the language intent and meaning were specific to naturopathic medicine
