Agenda Item 1

Call to Order/Roll Call/Establishment of a Quorum

Dara Thompson, ND, Chair, Naturopathic Medicine Committee (NMC), called the meeting of the NMC to order on October 5, 2021, at 10:12 a.m. A quorum was present and due notice was provided to all interested parties.

Agenda Item 2 Public Comment

There were no public comments for any items not on the agenda to discuss.

Agenda Item 3 Review and Possible Approval of Committee Meeting Minutes:

a) July 29, 2021

The Committee reviewed the July 29, 2021 meeting minutes. The minutes were approved as submitted.

Motion – Thompson / Second – D'Amico, to approve the July 29, 2021 meeting minutes as submitted. Roll call vote taken; motion carried 6-0-0. (YES – Thompson, D'Amico, Singleton, Davidson, Yoon, Worrels / NO – none / Abstentions – none).

b) August 30, 2021

The Committee reviewed the August 30, 2021 meeting minutes. The minutes were approved with minor amendments of adjournment time from "p.m." to "a.m.".

Motion – Thompson / Second – Davidson, to approve the August 30, 2021 meeting minutes with amendments. Roll call vote taken; motion carried 6-0-0. (YES – Thompson, D'Amico, Singleton, Davidson, Yoon, Worrels / NO – none / Abstentions – none).

Agenda Item 4 Executive Officer Update

a) Staffing and Committee Member Vacancies

EO Mitchell reported that the committee continues to have a staffing shortfall due to its sole, full-time staff temporarily working at a half-time basis. In order to resolve the staffing challenges the committee worked with DCA Budget and HR units to get us additional help. The Committee was able to secure a temporary solution by borrowing one staff from another program . The temporary staff started on September 1st.

Further, EO Mitchell reported that for the last 12-month period, the Committee has had 2 vacancies in its membership; including one (1) naturopathic doctor and one (1) physician (MD/DO) position. Both positions are Governor appointments. To date there have been no appointments, leaving the Committee with limited physician makeup to sit on the subcommittees.

b) Licensing Report

EO Mitchell provided a report of the licensing data:

- The NMC's total licensee count as of September 30, 2021:
- Active/Current Licensees 924
- Inactive/Current 24
- Delinquent 134

• Other (Retired/Canceled) – 185

The total number of licensees under the NMC's jurisdiction is 1,267.

c) Enforcement Report

EO Mitchell updated the Committee on the enforcement unit. Currently, the NMC has 86 total enforcement cases open. Of the 86 cases, 22 are against licensees, 3 are against applicants, while the remaining 61 cases are against unlicensed individuals.

The unlicensed activity still remains the largest portion of the NMC's enforcement caseload at 71% of the cases. Although the unlicensed activity has slightly increased since the last report, it is still lower than unlicensed activity over the last 5 years. It does appear that the educational material that the Committee sends out upon an initial complaint may be, in part, assisting to the lower numbers. We hope that continuing our educational and informational outreach campaign will keep the trend of lowering the unlicensed activity within our Committee.

Unlicensed activity consists of all the following:

- Using the naturopathic doctor (ND) title
- Not providing a written disclaimer of unlicensed practice to their client and having a signed copy by the client on file
- Providing Diagnosis
- Providing Treatment within the scope of an ND without the benefit of a license

There were 8 new cases received since the 08/30/2021 meeting and 0 cases have been closed in that time period.

Currently, the NMC has 25 total enforcement cases opened on ND licensees and applicants. Of the 25 cases, the breakdown of violation types are as follows:

- Advertising violations 4 or 16%
- Failure to update address with the committee 1 or 4%
- DUI related violations 4 or 16% (2 of these were based on applicants who
 provided prior conviction information during the application process)
- Unprofessional Practice 11 or 44%
- Records only 2 or 8%
- Death or patient harm 3 or 12% (although this includes death and patient harm, the 2 cases are patient harm and no deaths)

d) New Consumer Outreach Project Update

EO Mitchell provided an update on the Consumer Outreach campaign developed in partnership with DCA. The plan includes new articles that will be placed on social

media platforms and the Committee website. The outreach will also provide video reels providing consumers with the differences between licensed naturopathic doctors and unlicensed naturopaths.

Agenda Item 5 Update on Oversight (Sunset) Review

EO Mitchell provided a brief description of the reason for and the process of the Sunset Review conducted by the Senate Committee on Business, Professions and Economic Development and the Assembly Committee on Business and Professions. Ensuring that the Committee understands how the comprehensive process allows the Legislature to Review the laws and regulations pertaining to the committee and evaluate the committee's programs and policies; determine whether the committee operates and enforces its regulatory responsibilities and is carrying out its statutory duties; and examine fiscal management practices and financial relationships with other agencies.

EO also provided a copy of the *Background Information and Overview of the Current Regulatory Program* template used for the Sunset Review report. EO Mitchell advised that the report is due to the oversight committees by 01/05/2022. The report will provide a snapshot and substantive information about who the committee is, who the committee licenses, and how the committee performs its regulatory functions.
